

重庆瀚曦成立于2010年,于2011年5月获得重庆首批合格外资股权投资基金试点资格。

The Aktis Group currently includes Aktis Capital Advisory Limited ("Aktis Hong Kong"), Aktis Capital Singapore Pte. Ltd. ("Aktis Singapore") and Aktis (Chongqing) Investment Fund Management Co. Ltd. ("Aktis Chongqing").

Established in 2003, Aktis Hong Kong is a financial advisor that is regulated by the Securities and Futures Commission ("SFC"), according to the Securities and Futures Ordinance ("SFO"). Aktis Hong Kong holds the SFC Type 4 ("Advising on Securities"), Type 5 ("Advising on Futures") and Type 9 ("Asset Management") licenses, and its application for the Type 1 ("Dealing In Securities") license is currently in process.

Established in 2007, Aktis Singapore is an Exempt Corporate Finance Adviser and an Exempt Fund Manager, registered with the Monetary Authority of Singapore ("MAS").

Established in 2010, Aktis Chongqing is one of the first fund management companies that received Qualified Foreign Limited Partnership ("QFLP") status in May 2011.
